BE SURE to check if the hotel/campground still accepts dogs when making your reservations. Please make sure that you pick up after your dogs so that the hotels will continue to accept dogs.

Most Hide 'N Seek competitors are model guests, but it is becoming increasingly difficult to find motels that will accept pets due to bad experiences with excessive barking dogs. Please make it possible to have trials in the future. Never leave your dog(s) unattended in a motel room and please clean up after them. Your entry in future trials may be affected by failure to abide by these rules. Please know that AQ4U considers the motels and campgrounds PART OF THE TRIAL GROUNDS, so all rules that apply at trials will apply at motels and campgrounds.

**There will be a short break for lunch. Rats will be housed in the kitchen, so NO dogs will be allowed in there, but competitors may use the fridge and microwave.**

FLEXI LEASHES ARE NOT PERMITTED *at the trial site.*

### **SITE RULES:**

Please pick up after your dog and dispose of waste in appropriate containers outside the building. All dogs must be on a short leash and under control while on trial grounds except while showing.

## EVENT SCHEDULE Saturday & Sunday

Saturday class order: Four Corners, Maze Craze, Here, There, Everywhere, Traditional Hunt

Sunday class order: Four Corners, Chutes & Ladder, Urban Chutes & Ladder, Haystacks

Levels run together in each class – scents are always run rats (all levels 4 down to 1), followed by anise (all levels 4 down to 1), followed by hot dawg (all levels 4 down to 1). Any add-on runs will run directly after regular runs in each scent!

ADD-ON RUNS MAY BE OFFERED EACH DAY – ADD-ON RUNS ARE ONLY AVAILABLE FOR DOGS ENTERED IN THE TRIAL EACH DAY. A dog MUST be entered in the class in the regular run in order to do an add-on in that class.

**AWARDS:** Flat ribbons will be awarded for dogs placing 1<sup>st</sup> through 4<sup>th</sup> – dogs must qualify to place. All qualifying scores will receive an orange qualifying flat ribbon.

Crating will be available inside the building. Blind, deaf and handicapped dogs are eligible to compete. Bitches in season are NOT eligible to compete and are NOT allowed on trial grounds. After the trial closes, entry fees will not be refunded, except for injured dogs or bitches who come into season.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entries made without fees or waiver signature will not be accepted. There is a \$35 returned check fee.

Any dog of any breed or mix, 6 months of age or older, may participate in Hide 'N Seek Trials

Height divisions: dogs measuring up to 16" are considered "small" dogs. Dogs measuring over 16" are considered large dogs. Dogs are measured at the option of the Judge.

**Possessing or training with personal, live quarry or personal anise or hotdawgs are not permitted on the show grounds at any time.**

Exhibitors are responsible to clean up after their dogs or will not be welcomed back to AQ4U for any future events or classes.

Exhibitors are responsible for being ready to go from the blind area and waiting for the call to the gate when it is their turn to run. The judge need not wait for any dog holding up a class. AQ4U has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required. If you miss your run, you may have to forfeit your run. New running orders will NOT be created for people missing their run.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. Please check your confirmation carefully and make sure your information has been recorded correctly.

Agility Cues For You personnel assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, spectators or to any of their dogs, property or family.

Agility Cues For You reserves the right to refuse any entry for any reason. You will be notified by email and your entry fee will be returned.

Electronic collars and/or devices (including citronella collars), head halters, or flexi leads are not allowed on the trial site. Approved collars include flat snap or buckle of solid construction and leather or nylon leads. Limited slip martingale and single piece slip collars/leads are allowed. Harnesses are allowed.

Bring your own chairs.

The ring will be in the rat hunt building with crating in the big building.

**Tentative Set-up details:** We need 3 people to help set up the ring, ribbons and worker raffle. No job is hard. Worker vouchers will be awarded and you may save your crating spot. Set-up will be Friday, November 10.

**Tear Down details:** For each person who stays after the trial and helps us tear down, you'll receive a \$10 AQ4U worker voucher.

Briefings will be emailed to all exhibitors and will be posted in several places in the big building where crating is available. We may have a general briefing, if needed.

**We are offering Urban Chutes & Ladder at this trial! This will be a Chutes & Ladder course that will include 4-6 "urban" items on the course (buckets, towels, boxes) as "distractions" for dogs to hunt around. Any Q's received in this class will be counted as a normal "Here There" Q. THIS IS NOT CONSIDERED A SEPARATE TITLING CLASS! We are excited to be the only club offering Urban classes - Ann Embry's creation!**

**FROM SOUTH:** Coming from I-65, take KY-1526 W (exit 121). Turn left off of the ramp onto KY-1526 W. At the first stop SIGN turn left onto 1020 S (Coral Ridge Road). Go approximately 2 miles to Clear Run Drive. Turn right onto Clear Run Drive & Agility Cues For You will be the 2<sup>nd</sup> to the last building on your right.

**FROM NORTH:** Coming from I-65, take KY-1526 W (exit 121). Turn right off of the ramp onto KY-1526 W. At the first stop SIGN turn left onto 1020 S (Coral Ridge Road). Go approximately 2 miles to Clear Run Drive. Turn right onto Clear Run Drive & Agility Cues For You will be the 2<sup>nd</sup> to the last building on your right.

**FROM EAST:** Coming from I-64, take I 265 W to I-65 South. Take KY-1526 W (exit 121). Turn right off of the ramp onto KY-1526 W. At the first stop SIGN turn left onto 1020 S (Coral Ridge Road). Go approximately 2 miles to Clear Run Drive. Turn right onto Clear Run Drive & Agility Cues For You will be the 2<sup>nd</sup> to the last building on your right.

**FROM WEST:** Coming from I-64, take I 264 W to I-65 South. Take KY-1526 W (exit 121). Turn right off of the ramp onto KY-1526 W. At the first stop SIGN turn left onto 1020 S (Coral Ridge Road). Go approximately 2 miles to Clear Run Drive. Turn right onto Clear Run Drive & Agility Cues For You will be the 2<sup>nd</sup> to the last building on your right.

Try Before You Buy will only be offered at this trial:

**Must sign-up by 8:30 a.m., no exceptions.** Dogs new to Hide 'n Seek may run FOR FREE in one Four Corners class (first class of the day)! If you like it, you can register with Hide 'n Seek and keep that score. And if you sign up for the rest of the runs

offered that day, we'll even pick up ½ of the cost of your Hide 'n Seek dog registration fee!

**Masks!!** Masks are optional. \*\*Competitors wishing to wear masks must provide their own mask\*\*

**Bathrooms & Kitchen** – Both bathrooms will be open for competitors to use. The rats will be housed in the kitchen, so NO dogs will be allowed in there, but competitors may use the fridge and microwave.

**Judges:** If we receive enough entries to need a 2<sup>nd</sup> judge, other Hide 'n Seek judges may step in and help judge this trial.

**Rat dogs may hunt in tubes.** For those hunting rats, please note on your entry form if you will be hunting in tubes or boxes. You may do one or the other per day (not switch back and forth on 1 day).

**EXEMPTIONS!** Dogs with exemptions may choose to do all hides low OR all hides high! Please note on your entry form if your dog has an exception that you will be using.

FEO (for exhibition only) entries will be accepted at \$8 per entry. FEO entries do not receive Qualifying Scores and do not receive any ribbons.
